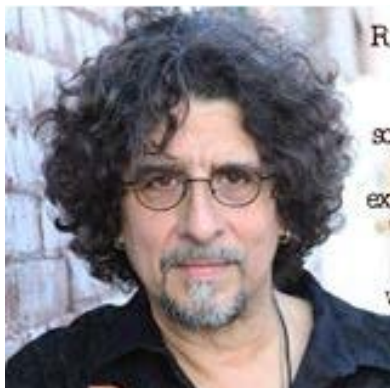

**PAYMENT REQUIREMENTS:** Deposit of \$250 per person (\$500 for single cabins) is required at time of booking. Final payment is due by July 1, 2017. **Special gift for those booking by April 1, 2017.**

**CANCELLATION POLICY:** No penalty for cancellations prior to July 7, 2017. \$250 per person penalty July 7-August 13, 2017. Penalty is 50% of cruise price between August 14-September 10; 75% to September 11-24. NO REFUND after September 24, 2017. Notice of cancellation must be received in writing by Fan Club Cruises within the time indicated. **Travel insurance is strongly recommended for this cruise. We provide Travel Insured International's Group Deluxe plan. All coverage and premium pricing is available on our website at [www.fanclubcruises.com/insurance\\_info.htm](http://www.fanclubcruises.com/insurance_info.htm). Payment is to be made at the time of your initial trip deposit and must be paid by check made out to Fan Club Cruises. Unfortunately, we are unable to offer the group insurance for residents of Texas, New York or the state of Washington. If you reside in one of these states and want insurance, you can purchase it directly on an individual policy at [www.travelinsured.com](http://www.travelinsured.com).**

**CHANGE OF ADDRESS:** If we are not notified of a change of address prior to our sending out documents and we need to arrange for redirection or replacement of documents, there will be a \$50 charge. Notifying the U.S. Post Office is not sufficient since the documents may be delivered by other companies.

**DOCUMENTATION REQUIRED:** Valid U.S. passport is required for U.S. citizens. Citizens of countries other than the U.S. should check with their embassy for proper documentation. Notify us if you are not a U.S. citizen or if you were born in another country. Your passport should be valid for at least six months after your return date. It is also wise to take a second government issued photo ID such as a drivers license since you might be required to show two forms of ID in some situations.

**AIR AND OTHER ARRANGEMENTS TO GET THERE:** Air fare rates vary with city of departure. Be sure you arrive at the port at least two hours prior to departure time (we highly recommend arriving earlier). Your return flight should leave no earlier than noon.

**RESPONSIBILITY:** Dan Navarro will be sailing on this cruise, providing entertainment for participants according to his agreement with Fan Club Cruises. Only serious illness, injury or death would prevent him from sailing. In the unlikely event that he is not able to sail, every effort will be made to provide an entertainer. Normal cruise line cancellation penalties will apply to passenger cancellations within 90 days of departure. If performances are cancelled, all passengers will receive a refund of the fee designated for the performers.
